* Goal: Respond to Functional Requirements for Authority Data
on the entity types of concern to art catalogers but problematic under
current AACR2-based rules (for example artists' groups). Deadline: By May
31, 2007. (*ARLIS/NA Strategic Plan objectives I.A., II.C., and III.*)

Status: Completed.

* Goal: Complete the introduction to "Best practices for
cataloging exhibition publications" and submit it to the Publications
Committee along with a revised version of "Titles and Statements of
Responsibility" for online publication on the ARLIS/NA web site (AWS).
Deadline: By Sept. 1, 2007. (*ARLIS/NA Strategic Plan objectives II.A., II.C.,
and IV.C.*)

Status: Ongoing. (Will be completed before May 2008.)

Notes: Feedback from the Publications Committee was never received, but the CAC has drafted an introduction based on early comments from the Publications Committee chair.

* Goal: Complete the "Notes" section and submit it to the Publications Committee for revision. Deadline: By May 2008. (*ARLIS/NA Strategic Plan objectives II.A., II.C., and IV.C.*)

Status: Will be completed before May 2008.

Notes: The "notes" section of the document is in the final draft stage.

* Goal: Represent ARLIS/NA and art library catalogers in responding to RDA ("Resource Description and Access," the successor to AACR2) as its chapters are released for public comment. Deadline: Ongoing as drafts of the RDA chapters are released. (*ARLIS/NA Strategic Plan objectives I.A., II.C., and III.*)

Status: Ongoing

Notes: The CAC has responded to all parts of RDA open for comment so far through its CC:DA liaison, Elizabeth Lilker.
